This Memorandum of Understanding has been made and executed at Ambala Cantt on this 11th day of February Month of 2023

Between

Social Education Voluntary Association (SEVA) Trust UK, a registered Trust having its registered office at Vill. Kesri Tehsil Saha, Distt. Ambala, through its Chairman cum Managing Trustee Naresh Kumar Mittal (hereinafter called the party of the first part or first party or SEVA Trust UK)

and

TIKA RAM PG GIRLS COLLEGE, SONIPAT, an Institute which was founded in 1992 and now being run by Tika Ram Education Society having its campus at Mission Road Sonipat, Haryana, through Principal of Institute (hereinafter called the party of the second part or second party or Tika Ram P.G. Girls College)

Whereas the first party is working as an NGO registered under Indian Trust Act since 2017. The first party is not for profit organization working in areas of Education, Health, Environment and Social Initiatives in States of Haryana and Punjab.

And the second party is educational institute established in 1992 to provide education and disseminate knowledge under various UG and PG level courses to girls.

Whereas the first party was desirous of working with second party for the development and education of the girls, women, youth, adolescents, children, and other disadvantaged groups in especially in areas of community health. So, this proposal of the first party has been accepted by the second party and it agrees to work with the first party for the betterment of the society.

Admitted

Now therefore, aforesaid parties have agreed to terms and conditions mentioned hereinafter in order to work together and for better coordination and accountability of the aforesaid purpose.

1.1 This Agreement shall remain in force for a period of 1 years only from the date of the execution hereof. This period and any extensions granted thereof by Tika Ram P.G. Girls College at its sole discretion and option shall be the said "TERM".

1.2 That during the first three months it shall function on probationary period closely monitored by a Coordination Committee, as described in clause 1.5.3 of this MoU. The parties agree that during the probationary period the Principal of Tika Ram P.G. Girls College shall upon recommendation of Coordination committee, have full power to terminate the present MoU. Thereafter pursuant to the mutual agreement between Partner Organization and Tika Ram P.G. Girls College, this Agreement may be extended for such further period as may determined at the relevant time.

1.3 If the any party wishes to terminate this MoU prior to the expiry of the Term then it shall give to other party a prior written notice of 1 month.

1.4 The Organizing activities shall be fully dedicated for the following areas or others as decided by Coordination Committee from Time to time :

1.4.1 Education : Girls, women, Psychology, Mental health, Learning enhancement, Personality Development, Problematic Child, Mentally disadvantage children, Adolescent issues, Career Counseling etc

1.4.2 To Organise Social awareness programmes, Blood Donation Camps, Social Events, Student Interactions, Scholarships Seminars, Orientation Session, Training, Rallies, Quizzes, Competitions etc. on the areas mentioned in 1.4.1

1.5 Role of Tika Ram P.G. Girls College

1.5.1 To provide its infrastructure free of cost for conducting the activities.

1.5.2 To assist in the identification of beneficiary through their authorized representatives for any scholarships, if any.

1.5.3 That the functional control shall be placed under Head, Department of Psychology, however the administrative Control shall be with the Coordination Committee consisting of the following members :

Principal / Person nominated by him	:	Chairman
Head ,Dept. of Psychology	:	Member
A Person Nominated by the SEVA Trust UK	:	Member

Role of SEVA Trust UK :

- 1.6.1 To assist in successful conduct of programs in campus or any place as decided.
- 1.6.2 To provide any printing material like poster, flex banner for the events, mementoes, appreciation Certificate for the event
- 1.6.3 To provide scholarships as decided, if any.
- 1.7 This is a non-financial MoU and if any expenses are involved, these shall be finalized before the conduct of such activity.
- 1.8 That in case of any dispute or difference within the parties, the decision of Principal of Institute shall be final and binding upon both parties.
- 1.9 That no new activity shall be undertaken without the prior approval of Principal of Tika Ram P.G. Girls College.
